St Patrick Catholic Church 18 Month Financial Status Update -- July 1 2022 to December 31 2023

FY 2022-2023

Thanks to you -- the faithful members of our St. Patrick family -- our financial status is very good. As we continue moving into a new era for our parish, you continue to care for each other and our parish family with generous donations to the offertory; to various programs within the parish, including the food pantry, holiday efforts such as food baskets and the St Nicholas tree, which reached out to residents of nursing homes; the St Vincent de Paul Society; special collections for needs identified by the USCCB; and our Sanctuary Beautification project.

You are also generous supporters of Bishop Golka and the Diocesan Ministry Appeal. Because of your outpouring of support to the diocese, we received a rebate earlier this year of \$30,051.23! The parish receives a rebate of 50% of contributions beyond our goal, and the money raised through the DMA will provide a great boost to the parish, as well as to the diocese. Thank you so much !!

An Enhanced Review was conducted by Waugh and Goodwin, LLP, for the fiscal year ending June 30, 2023. Our net income was approximately \$43,500 (excluding depreciation, a noncash expense). After adjustments for capital expenses and other items, cash flow was approximately (\$39,000). We continue to draw on reserves to fund some capital expenditures to maintain our aging physical plant.

FY 2023-2024

For the six months ending December 31, 2023, net income was \$105,000 based on internal analysis. This total was enhanced by donations to the Sanctuary Beautification project.

Some additional data points which might be of interest:

- We currently have approximately 1,140 families in the parish
- At 6/30/23 Net Assets were \$4,711,049 including land, building and equipment of \$3,982,426
- Offertory for the FY ending 6/30 was \$1,416,227
- Offertory for the six months ending 12/31/23 was \$758,845.26
- Diocesan Ministry Appeal rebate for CY 2023 was \$30,051.23
